FROM THE PRESIDENT-

DAY ON THE HILL - What a motivating day being in Nashville for Day on the Hill turned out to be. Since legislation is part of who we are as an organization, it was exciting to watch it in action. DOH Chair Zulfat Suara chose a list of topics to discuss, and those of us who were going to attend discussed them and narrowed down the list to 4 bills to focus on, with talking points listed to point out to the legislators when we met with them. We met with 7 legislators, which produced some positive attention for both the issues and our organization. Our collaborative efforts continue to produce positive results as we add additional women's groups to our list of friends. At our meeting with Speaker Beth Harwell we were joined by representatives of the TN Economic Council on Women, the TN Women's Political Collaborative and the Women's Political Caucus. It presented an impressive group to the Speaker. I hope next year's DOH event will be even bigger and better, and more of our members will be able to attend.

This is what we are all about after all!

Bills that we discussed with legislators are:

SB0580/ HB0253 Establish self-employment assistance in lieu of unemployment compensation.

SB446 / HB129 Expands offense of solicitation of a minor.

SB1073 / HB622 Plan to provide services to victims of human trafficking.

SB114 / HB1198 No preference in hiring based on race, gender or ethnicity by state government

Other bills that we support are:

SB541 / HB217 Broadening law enforcement training on interacting with mentally ill persons

SB668 / HB1077 Discourage Separation of siblings in foster care

SB737 / HB671 Termination of a rental agreement for victims of abuse & stalking

SB1286/ HB1265 Requires health insurance policies to cover screening, diagnosis and treatment of autism spectrum disorders.



In a message from Foundation reporting about its career and employment support initiative for women veterans and military/veteran spouses, Joining Forces Mentoring PlusTM, was saluted by First Lady Michelle Obama and the

Administration at Women's History Month events honoring the contributions of women veterans on March 19.

We will have a table at the Women Veterans Summit on April 13-14 and will be promoting the Mentoring Plus program and signing up women veterans who want to have mentors.
