## Day on the Hill our best event to date

In addition to working together on the Day on the Hill next year, I think it would be a great idea if we can work on meetings with our congressmen while they are not in session. There are issues impacting Tennessee women at the national level and meeting with the folks on their home turf will be great. Maybe one day, we can plan a joint legislative trip to Washington, D.C. Let me know if you will be interested and your

thoughts or comments.

Our victories

The following bills were passed and published: \*SB1794-Extends maximum sentence for repeat offenders- Pub Ch 693 (AWAKE).

\*SB 1660-Add the offense of promoting prostitution to the list of child abuse-Pub Ch 711.

\*SB1028-Changes the statute of limitation for prosecuting someone for trafficking or soliciting sex. Pub Ch 416.

The following bills have not been published, but they have passed and are now transmitted to the governor: \*SB2084- Elimination of the statute of limitation on rape committed after July I, 2014. This is a major victory that ensures that victims get justice no matter how long it takes \*SB1940-Requires LEA required to provide Family Life Curriculum to send a report to the state board (WPC initiative)

Our defeats

\*SB0804-Prohibits TN from participating in any Medicaid expansion. This bill passed after 8 amendments in the House and 9 in the Senate. We believe despite the adjustments, this is still a bad bill for Tennesseans- Pub Ch 662

\*SB1681- Creates a voucher program for payment of approved testing cost failed in the Senate education committee where Senator Tate who is the sponsor of the bill is the vice chairman. Go figure.

#### No actions

The following bills just did not get acted on before the assembly adjourned:

\*SB 1428- creates a grant to assist veterans with creating

and opening small business. \*SB 2354-Revises the provisions governing harassment/bullying in schools

\*SB1973 Requires publishing of reports concerning awarding of purchases to minority, women and disabled veterans.

What is disappointing is that the above bills are common sense bills – no brainers.

It is indeed a shame that our legislators could not make the time to pass bills that help veterans, reduce bullying and help women and minorities.

The lesson is that there are

no common sense bills. If we leave it to our legislators, those bills that we think are important may fall through the cracks (politics). It is therefore important that we keep the pressure on.

Go and visit your legislators at their district offices while they are on break. Again thanks to everyone for making this year's effort a success and we hope we can count on you next year.

"Lately the Tennessee legislature has had a barrage of 'attack bills', I call them attack bills because they attack public education; they attack children, the poor, the sick and the needy," Rice said. "Then there's the Medicaid expansion. They are not expanding Medicaid. That hurts a lot of people below poverty level--- the working poor. It doesn't help our rural hospitals either. They no longer get reimbursed for indigent care and that may spell the end for many of them. Those are just a few of the things I feel strongly about."

She always attends Day on the Hill and was there in February visiting our legislators at one of the best attended Day on the Hill events in several years, according to Zulfat Suara, Legislative Chair.

For many years, she has been a professional social

worker serving the poor, the sick and the mentally ill. When she moved to Tennessee in 1988, she worked at St. Jude Children's Research Hospital helping children and their families adapt to catastrophic illness. She relocated to Hardeman County in 2000 and commuted to work for Professional Counseling Services, providing therapy and crisis services in their Ripley and Somerville locations.

She began working for Quinco Mental Health in 2004. In 2008, she became Director of Crisis Services over a five-county area.

"I'm retired from Quinco, but I remain on their crisis response team," Meryl said.

Because she often works with those whose rights are violated and whose medical services are diminished by cutbacks, she is dogged in her determination to be politically active.

"I ran for State Senate, District 26, and I received 40 percent vote against an incumbent in 2012," she said. "I was pleased with the showing. I got a late start. I was looking for someone else to run, but I ended up running because no one else would."

"If I had gotten an earlier start and had been able to contact more people, I think I would have done better and possibly would have beat her. It's hard to get the word spread in eight counties. So many people vote the party and pay no attention to who is running. The district leans Republican anyway," she said.

When Rice ran, she was endorsed by the 55,000 member Tennessee Education Association, Tennessee State Employees Association, and The Jackson Sun, among others. She chaired the Hardeman County Democratic Party from 2005-2011 and was vice-chairman.

She helped organize the charter chapter of Hardeman County Democratic Women in 2009 and is

president now. She was elected delegate to 2012 Democratic National Convention, and she cochaired Greg Rabidoux's U.S. Congressional campaign.

As president of Hardeman County BPW, she'd "like to continue the work for women that is BPW's focus. All the women in BPW are interested in getting equal pay for equal work. Our efforts need to continue to be focused in that direction. I would also like to see more women in business, period."

She's also excited about the newly designed BPW/TN business training conference coming up June 13-15 in Jackson that will offer education tracks and business training sessions to non-traditional women students and to women military veterans, and male veterans as well.

The fact that 1 in 5 women returning from

## Web page is always changing, growing

When asked to be webmaster again for BPW/TN, I took the opportunity to look at the past websites and identify some of the challenges the organization has experienced with maintaining a communication outlet.

One of the issues I personally struggled with several years ago as webmaster was functionality and convenience. At that time, when notified of a change, I had to wait until I returned to my home computer to update the website. Why? Because both the software and data were contained on my home computer.

Today things are much different. Web based software allows us great-

er flexibility and access to our data as long as there is an internet connection. This means, when I receive an email message stating "my name is spelled wrong", I can log into our Weebly account, make the change, and publish within minutes.

Why use Weebly for a website? First, it is easy to use and provides valuable videos on how to build a professional looking site from scratch. Second, the drag and drop functionality makes it easy to move items around on a page for an eye catching landscape.

Third, probably one of the most important reasons the price. For those with a limited budget, there is a free version which allows you to get online with no invest-ment. The purchased versions provide even more advanced tools to make your online presence more professional at an affordable price. For example, the paid version provides a more robust means to offer visitors online registration forms to events such as our annual convention.

Our website is more than just an informational tool for our visitors. It is our storefront to letting the world know who we are and what we do.



#### PREAMBLE

The Equal Rights Amendment, as authored by Alice Paul, shall stand first, foremost, and above all other items which may appear on the platform of this Federation until equal, legal rights for women and men become guaranteed in the United States Constitution, because all statutory law derives there from.



#### THE EQUAL RIGHTS AMENDMENT

Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex.



#### **PLATFORM**

#### **Economic Equity**

Actively work to support equal educational opportunities; equal treatment for women in all areas of employment, including adequate retirement benefits, improved programs for women re-entering the workforce, and implementation of equal pay for work of comparable worth.

#### **Health**

Actively work to strengthen and enforce legal protection for full access to all health care services including reproductive choice, funding for research into and protection for women's health care and educational programs concerning women's health issues.

#### **Civil Rights**

Actively work to pass legislation, which will ensure equal rights and remedies for women in all phases of their lives, including support of affirmative action programs; and eliminate all forms of harassment against individuals.

#### **Dependent Care**

Actively work to strengthen and improve enrichment programs, physical facilities, and funding for affordable quality dependent care of all ages.

#### **Victim Rights**

Actively work to strengthen and enforce legal protection for all individuals who are victims of violent acts including domestic and/or sexual violence; promote violence prevention programs; support services and facilities for survivors of this violence and the funding thereof; and support legislation, which provides compensatory and punitive damage awards to victims.

Actively work for the election of and appointment to policy-making positions those who support the BPW Legislative Platform.





active duty cannot find a job is an issue that she is glad BPW/TN is working on, offering resources and mentoring at the convention.
"I certainly hope the convention will be successful. Even if we're not talking about women going into business themselves, they need to be prepared to go into the work force. Before we can bring in industry and jobs, we have to have a prepared workforce." Rice said

workforce," Rice said.
Meryl and her husband
Randall continue to be community activists. "When
health insurance markets
opened, my husband and I
felt we should really get involved. We got training to
help people enroll," she said.

"About a week before the enrollment period was to open, the state handed down "emergency rules" saying that there were certain criteria people had to meet before they could talk to

anyone about the marketplace. If people did not meet the criteria and mentioned the marketplace to anyone, they were subject to a penalty of \$1,000 per occurrence," Rice explained.

"Randall and I were among the plaintiffs in a lawsuit filed through the Tennessee lustice Center alleging the state was trying to take away our First Amendment rights to free speech. Within a few days the state back-pedaled and said the regulations weren't meant to include everyone, but for certified counselors and navigators only; and that as long as we did not represent ourselves as being either one of those or in any official capacity, we could talk about anything we wanted to. Later a judge incorporated the state's settlement with us in a judicial

So eventually she and her husband held eight community events to inform people about the health insurance marketplace.

"There were also certified counselors at various community medical facilities that helped people enroll. But with one person for put on Facebook that we had enrolled someone and three counties, they had more than they could do," she said. "So we got the word out that anybody who wanted help, we'd help. We enrolled 40 or so people in our home area. Each time we enrolled someone, I'd the plan they had chosen."

People started calling them from different states and other counties.

Meryl's goal is that she wants to see women succeed, to get the education and business support they need, and to work with our legislators to get the laws passed that we need.

She's running for the Democratic Party State Executive Committee Women this year. Her election will be in August for District 26.
