Women's March groups plan January events in Tennessee

Women's March coalitions in Tennessee, formed in 2017 to show strong support on issues not considered priorities of Donald Trump, will have events this month in Knoxville, Nashville and other communities on the first anniversary of the president's inauguration.

The Women's March Coalition of East Tennessee will sponsor festivities on Knoxville's Market Square beginning at 1 p.m. Sunday, Jan. 21, that will include a walk to the John J. Duncan Sr. Federal Building on Cumberland Avenue and back. "This year is a celebration and recognition of all of (our) work. All of the activists really stepped up in 2017 to make a difference. We want to celebrate the positive. Jan. 21 is exactly one year (of the Women's March)," said Coalition co-chair Caroline Mann. The 2017 Women's March turned out to be a world-wide event the day following Trump's inauguration in support of raising the minimum wage; concern on environmental issues, particularly climate change; women's, immigration and LGBTQ rights, and social justice issues. Thousands participated in Knoxville when only hundreds were expected by organizers. A symbol of the movement for women is a pussy hat, a knitted cap with cat ears. The Loudon County Democratic Party is encouraging supporters on Facebook to "get those pussy hats ready" to wear Jan. 21 on Market Square. Other groups involved that day include Indivisible Neal described those participating in Nashville East Tennessee, which opposes the Trump agenda by lobbying Congress; Organizing for Action, an outgrowth of former President Barack Obama's campaigns, which has been most active in trying to keep the national Affordable Care Act from being gutted; and the 2017 City Council Move-

ment, which takes credit for helping to elect Council members Seema Singh-Perez and Gwen McKenzie last year.

Mann said some participants in movements this year have included workers and faculty members at the University of Tennessee who opposed a state plan for outsourcing facilities. Chancellor Beverly Davenport announced in November the Knoxville campus would not participate, a decision that has been criticized by UT President Joe DiPietro and some members of the UT board of trustees.

"I hate to think it's become a political thing," said Mann, who works in enrollment management at UT. "She (Davenport) did the right thing, was responsive to the community and was responsible." At the Market Square activities, recognition will be given to individuals and organizations that have focused on different community issues. Information on making nominations for the reSister of the Year is on Facebook. In Nashville, Women's March 2.0: Power Together Tennessee, which represents a number of individuals and organizations, will have its events on Saturday, Jan. 20, said Darlene Leong Neal, Women's March Tennessee coordinator and Power Together Tennessee organizer. Participants are expected from Knoxville; Neal said she and others will travel to Knoxville the following day to attend events here. She said marches also will be held Jan. 20 in Chattanooga and Johnson City. The Nashville activities will focus on action for 2018, including elections. Workshops and training will be held beginning at 8 a.m. CST on the Avon Williams Campus of Tennessee State University; luncheons will be held on geographic or issue-based themes, and then a march will begin at 2 p.m. at the public square at the Davidson County Courthouse, with a rally at 3 p.m. at Bicentennial Mall. A fee will be charged for the workshops and luncheons, although organizers emphasize it is not required to participate. More information is at TnPowerTogether.org.

activities in 2017 as first-time activists and "voices from the margin." She said she is encouraged by the closeness of a special election recently for the state Senate 17th District in which Republican Mark Pody beat Democrat Mary Alice Carfi by about 300 votes in a heavily Republican district. One GOP strategist has said it's a "wake-up call."

<u>Aspiring Leaders</u> <u>of Tomorrow</u>

BPW/TN Aspiring Leaders of Tomorrow (ALT) is a program to recognize the skills and support the career development of **Tennessee's future female**

leaders. The program is open to any female resident of Tennessee who:

~~Is a High School Graduate or holds a GED equivalency;

~~ls age 35 or under;

~~Is enrolled in a post-secondary institution of higher learning such as any accredited 4-year college, community college, technical school or in a recognized apprenticeship program. The institution of higher learning does NOT have to be in Tennessee.

The 1st , 2nd, and 3rd place recipients will each be awarded a textbook stipend.

Program Details

Interested applicants must fill out an application and submit a 400-500 word essay on one of the topics recommended by the ALT committee. Topics will be chosen by the committee each year.

Applications and essays must be postmarked by March 1. Any submissions after the deadline will be returned to the applicant unopened.


Based upon the written essays, finalists will be chosen by the committee by April 15. All participants will be notified of the committee decision. Finalists must prepare and submit a 4-minute videorecorded speech based upon their written topic by May 15. Video recorded speeches must be submitted in MPEG, AVI or MOV (QuickTime) format.

Legislative Platform 2017-2018

PREAMBLE

The Equal Rights Amendment, as authored by Alice Paul, shall stand first, foremost, and above all other items which may appear on the platform of this organization until equal, legal rights for women and men become guaranteed in the U. S. Constitution, because all statutory law derives from there.

THE EQUAL RIGHTS AMENDMENT

Equality of rights under the law shall not be denied or abridged by the United States or by any state on account of sex.

PLATFORM

Economic Equity

Ensure pay equity, equal educational and economic opportunities at all stages of life; and promote affordable, quality dependent care to help ensure economic self-sufficiency for women.

Health

Ensure reproductive choice and full access to all reproductive health services and education; ensure **funds for research into and protections for women's** health care needs; and encourage the development of a national health care plan recognizing the special health care needs of women.

Civil Rights

Ensure equal rights and remedies for women in all phases of their lives; support affirmative action; eliminate sexual harassment and violence against women.

The organization supports issues of importance, which promote the goals, objectives, and mission statement of the Business and Professional Women of Tennessee, Inc. (BPW/TN).

The placement of the Platform items in no way indicates importance or priority of one item above another.

January Highlights in US Women's History:

January 3, 1949 – Margaret Chase Smith (R-Maine) starts her tenure in the Senate, where she stays in office until 1973, became the first woman to serve in both the House and Senate as she previously served in the House (1940-49) January 5, 1925 – Nellie Tayloe Ross is inaugurated as the first woman Governor in U.S. history (Gov. of Wyoming) January 7, 1896 – Fanny Farmer's first cookbook is published in which she standardized cooking measurements January 7, 1955 – Marian Anderson is the first African American woman to sing at the Metropolitan Opera January 8, 1977 – Pauli Murray is ordained as the first female African American Episcopal priest January 11, 1935 – Amelia Earhart makes the first solo flight from Hawaii to North America January 12, 1932 – Hattie Wyatt Caraway (D-Arkansas) is the first woman elected to the U.S. Senate, becomes the first woman to chair a Senate Committee and the first to serve as the Senate's presiding officer January 25, 1980 – Mary Decker became the first woman to run a mile under 4 1/2 minutes, running it at 4:17.55 January 29, 1926 – Violette Neatly Anderson is the first black woman to practice law before the U.S. Supreme Court
