Women's 99th Anniversary Right to Vote Celebrated

Nashville Women's Suffrage Monument Wreath Laying Ceremony by. Jacque Hillman

A crowd of about 200 people gathered at the Tennessee Woman Suffrage Monument on Saturday, Aug. 24, in Nashville's Centennial Park to celebrate the 99th anniversary of Tennessee's ratification of the 19th Amendment.

Taking part in the celebration were members of the Tennessee Woman Suffrage Monument board who began fundraising in 2013 for the monument created by renowned sculptor Alan LeQuire. Jacque Hillman, who has served on the board since its inception, is president of Jackson Area BPW and past state president of BPW/TN 2013-2014. The TWSM board conveyed to Metro Nashville on Aug. 20 the statue of five nationally known suffragists, Carrie Chapman Catt, Juno Frankie Pierce, Sue Shelton White, Abby Crawford Milton and Anne Dallas Dudley.

"The celebration was a grand tribute to suffragists who fought the country's largest nonviolent revolution to pass the 19th Amendment, and who rallied their forces to make this happen even though they didn't have the right to vote. It's a tribute to the donors whose financial commitment brought this monument to fruition and tooard members who have dedicated so much time to this project," said Hillman."And certainly, we owe a vote of thanks to Metro Nashville supporters who grasped the vision, saw the importance of this anniversary to our state and nation and who saw the promise of woman suffrage heritage tourism."



The occasion also commemorated major donors such as the Eskind Family and organization donors across the state, including Business and Professional Women of Tennessee Inc., who placed yellow rose wreaths at the base of the monument. State President Lee Ann Gaddis presented the wreath

Speakers included: Jessica Turk of WNPT, which is creating a documentary on the 1920 ratification; Monique Odom, Parks Director; Carole Bucy, Metro Nashville Historian; Nashville Mayor David Briley; and Yvonne Wood, TWSM board president.

On Aug. 15, Mayor David Briley announced the creation of the Mayor's Council on the State of Women to commemorate the 100-year anniversary of woman suffrage. The Council will report to the Mayor's Office on women's issues and will focus on increasing civic engagement and access to opportunity for women throughout and beyond the centennial year, August 18, 2019, to August 18, 2020. Two TWSM board members, Yvonne Wood and Alma Sanford, will serve on the Council.

"Nashville has been leading on progressive issues for years, and the Council on the State of Women will continue that tradition," said Mayor Briley.

Hillman is co-founder of the national award-winning tnwomansuffrageheritagetrail.com website along with Paula Casey, TWSM board member. They encourage BPW/TN members to submit information relating to woman suffrage and the people/events in their areas to the website.

"The eyes of the nation will be on Tennessee for this 100th anniversary celebration because Tennessee was the Perfect 36, the last state that could pass the amendment," Hillman said. "Many tourists will come to Tennessee to tour our historic sites. We want them to visit our suffragist monuments in Memphis, Jackson, Nashville, Clarksville, Chattanooga and Knoxville. But if there are more sites across Tennessee, our BPW/TN members can help provide that information."

In August 1920 in Nashville, Tennessee, the 19th Amendment was passed in a turbulent, nail-biting legislature session, by one vote. The result: women in the United States finally had the right to cast a ballot. How long have you been a member of BPW? Since 2004


What local organization are you a member of? Elizabethton

Former Jackson Mayor Jerry Gist chose her serve as the chair of the Safe Neighborhoods Task Force where she worked on programs to ensure families had safe places to live. She has recently been appointed chair of the newly created Community Redevelopment Agency of the City of Jackson, designed to eliminate or prevent slum and blight in Jackson.

She plays an active role in many community organizations including past board president of Youth Town of Tennessee, The STAR Center, the Jackson Arts Council, Big Brothers Big Sisters of Madison County, Jackson-Madison County Sports Hall of Fame, the Jackson Family YMCA Regional Board, and The Bank of Jackson. Vicki is currently the Chair of the Board of the WestTenn Bancorp Holding Company.

She is past president of the Jackson Rotary Club and past District 6760 Assistant District Governor. Vicki is past chair of the Jackson State Community College Foundation, and the Jackson/Madison County Library Foundation. She serves on the Union University Board of Regents and on boards of the Jackson Arts Council, the West Tennessee Housing Resource Network, and is a graduate of WestStar Leadership Program. She is active in The University of Alabama West Tennessee Alumni and Friends Chapter.

National Business Women's Week



HISTORY & PURPOSE

Business and Professional Women's celebrates National Business Women's Week (NBWW) to honor the contributions of working women and employers who support working women during the third week in October. This serves as an opportunity to highlight the progress woman have made as professionals, business owners, and entrepreneurs.

National Business Women's Week provides BPW with an opportunity to facilitate facilitate discussions on the needs of working women, share information about successful workplace policies, and raise awareness of the resources available for working women in their communities.

The celebration of National Business Women's Week has helped to promote leadership roles for women and to increase opportunities for our advancement professionally and personally.

The concept of National Business Women's Week originated with Emma Dot Partridge, Executive Secretary of the National Federation of Business and Professional Women's Clubs from 1924 to 1927.

The first annual observance of NBWW was held April 15-22, 1928, when National President Lena Phillips opened the week with a nationally broadcast speech. She stated that the purpose of the week was "to focus public attention upon a better business woman for a better business world." From this early effort, NBWW has grown into a nationwide salute to all workingwomen.

In 1932 U.S. President Herbert Hoover was the first president to issue a letter recognizing NBWW and the contributions and achievements of workingwomen. And, in 1938, NBWW was moved to the third full week of October.

The program for the first observance of NBWW in 1928 included:

- Legislative Day devoted to national, state and local legislation of interest to women
- Education Day devoted to emphasizing the need for equitable educational opportunities
- Club Rally Day for prospective new members
- Community Day honoring leaders in the community
- Goodwill Day devoted to working with other women's organizations.

How can your local celebrate National Business Women's Week

- Host a special October BPW meeting in celebration of NBWW at a locally female owned business.
- Share photos from your meeting or feature a one of your business members on social media and use appropriate hashtags such as #bpw #bpwtn #nationalbusinesswomenweek #femaleentreprenuers
- · Host a fundraiser for a women's charity or event.
- Host a women's panel. You can have 3-4 women briefly speak at the panel about their secrets to success and then answer questions.
- Attend a local women's leadership conference.
- Promote local networking opportunities for women within your community.

- Registration fee of \$___TBA____ applies only to those who pre-register at least five days prior to the formal opening of
 the board meeting. Registration fee after that time shall be \$___TBA____.
- Non members attending only any one or or more stated meals shall not be required to pay a registration fee.
- A request for refund of paid pre-registration and stated meals may be approved only if made in writing to the president and
 the interim board chair by the person requesting refund, received no later than 72 hours prior to the first business
 meeting.
- Half of only the registration fee will be approved only if made in writing to the state president and received no later than 24
 hours prior to the first business meeting.
- Registration fees are not transferable from one member to another unless the transfer occurs between members of the same Local Organization. Transfers within a Local Organization will be allowed without prior approval of the state president.
