

Why did you decide to run for state president?

I have been honored to serve twice--2000-2001 and 2016-17. The first time it was a way for me to promote the issues that were important to me and to develop leadership skills. At my work there were a lot of folks of approximately my age and experience and therefore little room to grow. The second time, no one had filed to run and I thought the organization needed me.

What were your goals for your term?

The first time-- establish a website. We did. Looking back it was not great but we have not been without one since. We also worked to pass legislation. I think that year was a state law that made divorcing spouses notify each other if their health insurance coverage had ended. Also, around that time, we worked to enhance the penalties for spousal rape. The second time, we established the Tennessee Business and Professional Women's Education and Scholarship Fund. This year we had enough money to award two scholarships. What is your favorite memory of your term as state president? I was installed as president the first time in Gatlinburg. I remember presiding over the Post Convention Board by stripping off my black suite jacket to reveal a Rosie the Riveter--" We Can Do It" Tee shirt and saying loudly, Good morning, Tennessee. It was cool to be installed again in Pigeon Forge and going out shopping for executive officer gifts at the Moon Pie Store (spur of the moment), giving money to Thistle Farms, and Blue Monarch and saving money for the 100th Anniversary celebration.

What advice would you offer to the current or future state presidents? Stay positive.

What do you do now?

I am Senior Managing Attorney with West TN Legal Services. I am a Board Certified Social Security Disability Law Specialist. I am BPWTN's parliamentarian.

How long have you been a member of BPW? 32 years.

What local organization are you a member of? Jackson Area

What would you like to see for the future of TN BPW?

I would like for BPWTN to continue to be a place for leadership growth particularly through serving as officers and committee chairs. I would like for BPWTN to continue to train and education its members and the public to be active in public policy. I want us to continue to provide scholarships both to mature women 25 and older through the TN Education and Scholarship Fund and to Aspiring Leaders of Tomorrow ages 18 through 35.

NOMINATIONS FOR STATE OFFICE 2020-2021

In January each local organization and other BPW/TN members will be receiving information on candidates for office for the 2019-2020 BPW/TN year. Each Local Organization member seeking office must be endorsed by her local organization and complete the form correctly. Members at Large who wish to run for state office may obtain a Data Form for Members at Large from the nominations committee. [Members at Large are not eligible for the offices of Regional Director.] Members at Large who wish to be a candidate for state office should send their forms to the committee chair, Virginia Bates. Forms are also posted on the website www.bpwtn.org. Forms in duplicate, and pictures for candidates for state office and regional director must be returned to the nominating committee chair or committee member no later than April 10, 2019. Please send digital copies of pictures. All candidates for state office or regional director must have been a member of BPW/TN for at least two years as of the convention at which they are candidates. Candidates for line officers, President, President-elect and 1st or 2nd Vice President, must have served as president of a local organization, current or past, in Tennessee. [Bylaws, Article XII].

WHY CAN'T MOTHER VOTE?

JOSEPH HANOVER AND THE UNFINISHED BUSINESS OF DEMOCRACY

On August 18, 1920, thirty-year-old state Rep. Joseph Hanover of Memphis walked into The Hermitage Hotel in Nashville to be greeted by cheers and jeers. Joe Hanover had become the nation's leading male voice in the fight for woman suffrage and the passage of the Nineteenth Amendment. The most powerful forces in Tennessee opposed him. But Joe Hanover, a Polish immigrant, was not going to back away from the fight. Joe asked: "Why can't Mother vote?" Before the vote was over, he'd be assaulted in a hotel elevator, and Gov. A.H. Roberts assigned a bodyguard to the young legislator and attorney.


Renowned Tennessee author Bill Haltom decided it was time to tell the story of Joe Hanover's role in keeping the votes together for ratification of the Nineteenth Amendment.

Haltom's book, "Why Can't Mother Vote? Joseph Hanover and the Unfinished Business of Democracy," will be released Dec. 23, 2019. The book launch is from 6 to 7 p.m. on Jan. 7, 2020, at Bounty-on-Broad in Memphis, a well-known restaurant that was once the Hanover Dry Goods store.

The book has already received a five-star review from Readers Favorites: "Why Can't Mother Vote? is the perfect blend of historical accuracy and brilliant writing."

Elaine Weiss, author of "The Woman's Hour," wrote this about the book: "For a century, Joe Hanover has remained a forgotten hero of American democracy, but now his inspiring story is revealed in William Haltom's 'Why Can't Mother Vote.' As a young immigrant to Memphis who believed in the American Dream of equality and opportunity for all, then as a young legislator willing to stand up for justice against fierce opposition, Hanover became a champion of women suffrage. When the fight to ratify the 19th Amendment comes to Tennessee in 1920, Hanover will rise to lead the suffragists' fight in the statehouse. Haltom helps us recognize Joe Hanover as a true patriot, and we need the lesson of his life more than ever."

"Why Can't Mother Vote?" is receiving national attention. National Women's Suffrage Commission is sponsoring the Joe Hanover bust on the Memphis Suffrage Monument, and they plan to promote Bill Haltom's book through their website. Haltom is the author of six books and has been a newspaper and magazine humor columnist for over 25 years. He has served as chair of the editorial boards for four magazines, including the ABA Journal, the flagship publication of the American Bar Association. Bill lives in Memphis with his wife (Judge Claudia), his daughter (Princess Margaret) and his two beagles (Atticus and Scout). www.billhaltom.com whaltom@comcast.net

If you attended State Convention last year you may remember the granola samples in the Swag Bags- it is made by the ladies in the Blue Monarch program. Blue Monarch has a mission to provide a long-term residential and therapeutic community for women and their children. Their goal is to break adverse cycles and to help these women rebuild their families.

They work with women and children who are dealing with addiction, domestic violence, and economic hardships while focusing on providing a nurturing environment to achieve sobriety, enhance mother/ child relationships, and build better life skills. They believe destructive cycles can be broken and want to serve women who have a desire and commitment to change.

The program started in 2003 but it really began years before that in 1995. Susan Binkley had a powerful dream that described in detail a program like Blue Monarch. At the time Susan realized the dream was significant but didn't fully understand until years later when the dream became a reality.

The property is located in Middle Tennessee near Monteagle mountain. It is actually a 50 acre piece of property that used to be a bed and breakfast. It came completely furnished and provided everything needed to begin serving the women and children. Since 2003 they have served over 775 women and children from across the state.

Out of the Blue Granola provides onsite employment for the women participating in the Blue Monarch program. It is an all-natural product, carefully baked by hand using local honey. Inside every bag is a photograph of one of the women who bake the granola with her special story of recovery on the back. For this reason, it is often called "gift granola."

However, it is also called "Granola with a Purpose" because it helps Blue Monarch and the women and children they serve in a variety of ways:

- It offers job training and flexible employment opportunities at a time when it would be quite difficult to obtain or maintain a job.
- Out of the Blue Granola helps to develop a positive work history despite possible felony charges.
- Once the women begin to earn an income, they are also able to contribute a portion back to Blue Monarch to support the services they have received.
- Blue Monarch gains financial support from folks who learn about the program through purchasing the granola.
- Many of the women of Blue Monarch have had poor work histories or struggled to earn an honest income. This job provides a valuable opportunity to gain self-respect and develop self-sufficiency, often for the first time.
