Rachel and Daniel Mullen are the powerhouse duo behind the company. Rachel needed natural body products that wouldn't irritate her skin and she started making her own in their kitchen. She taught herself about soap making, essential oils, and lye and was determined to create a soap line that would contain only natural ingredients.

Nashville, Tennessee is all about the music so it isn't a surprise that the sights, sounds, and people of Music City have inspired the products. You'll find a little piece of Tennessee in every sud. While we are on the subject of suds- you won't find any artificial colors, scents, or additives in these soaps. They also take pride in not using harsh chemicals or skin-irritating additives and they use essential oils and food grade colorants.

As for the products- they offer a variety of soaps with witty names like "Friends In Aloe Places" and "Stand By Your Mandarin". If you browse their website musiccitysuds.com you'll find gift and travel sets, beard care, bath salts and bombs, lotion, lip balms, deodorants, and natural bug repellant. Their creativity really comes through in the packaging. Using repurposed music note paper as soap bar wrappers and recycled cigar boxes for gifts has helped them embrace an eco-friendly way of packaging products.

### EQUAL RIGHTS AMENDEMENT RATIFICATION

The Virginia House and Senate both voted to ratify the Equal Rights Amendment—the 38th and final state needed for ratification! The ratification came after a 28-12 vote by the Virginia Senate and a 59-11 vote by the Virginia House.

The Equal Rights Amendment was passed by Congress on March 22, 1972 and sent to the states for ratification. In order to be added to the Constitution, it needed approval by legislatures in three-fourths (38) of the 50 states. After 48 years Virginia became the 38th and final state needed for the ERA Amendment to be added to the Constitution.

The Equal Rights Amendment is a proposed amendment to the United States Constitution designed to guarantee equal legal rights for all American citizens regardless of sex. It seeks to end the legal distinctions between men and women in terms of divorce, property, employment, and other matters.

Wangari Maathai was the first African American woman to receive the Nobel Peace Prize. She was also the first female scholar from East adn Central Africa to take earn a doctorate, and the first professor ever in her home country of Kenya.



Mary Kenner was an African-American inventor who revamped the world of feminine care with the invention of teh sanitary belt (maxi-pad). Although her invention gained a lot of interest it was rejected by muliple companies because she was African-American. She also invented other household items such as the tissue paper holder, as well as a back washer that mounted to the wall of the shower.

### **BLACK HISTORY MONTH**

Black History Month is an annual celebration of achievements by African Americans and a time for recognizing the central role of blacks in U.S. history. Also known as African American History Month, the event grew out of "Negro History Week," the brainchild of noted historian Carter G. Woodson and other prominent African Americans. Since 1976, every U.S. president has officially designated the month of February as Black History Month. Other countries around the world, including Canada and the United Kingdom, also devote a month to celebrating black history.



Daisy Bates led the charge to desegregate the allwhite Central High School in Little Rock, Arkansas in 1957.



Shirley Chisholm was the first African-American woman elected to Congress in 1968. She was also the first woman to campaign for the Democratic Pesidential nomination in 1972. She was an advocate for women and minorities.


# The Tennessee Blue Book 2019-2020

New Blue Book Commemorates 19th Amendment Anniversary.

The 2019-2020 edition of the Tennessee Blue Book is now available and it honors the 100th anniversary of the ratification of the 19th Amendment granting women the right to vote. Secretary of State Tre Hargett said the commemorative edition recognizes the steadfast efforts of Tennessee suffragists and the pivotal role Tennessee played in ratifying the amendment. The cover of the book — yellow — also honors the symbolic color of the national women's suffrage movement.

Published every two years, the Blue Book is the definitive manual on Tennessee state government featuring biographies of elected and appointed state officials, census data, election statistics, state history and more.
