MARTHA ERVIN CANDIDATE FOR PRESIDENT ELECT

Rationale: Removing requirement that a regional director must be a member of a local. This responds to the increase in members at large and fewer numbers of local organizations.

Rationale: This position has not functioned in recent years. Multiple other changes would be required if this motion passes. This will require a proviso that the BL Committee be allowed to make other appending changes to the BL made necessary if this amendment passes.

THE JOHNSON CITY TN SUFFRAGE COALITION'S LEGACY PROJECT

Fall 2020

The mural as depicted above will be placed on Ashe Street at the intersection of Earnest Street and carries the following story: Depicted in three stages, the mural honors the history of the Women's Suffrage Movement with a focus on the Johnson City and Tennessee stories. commemorates the centennial anniversary of the passage of the 19th Amendment through the celebration of a diverse and cohesive movement that continues to impact the social standing of women in our society today. This mural centers around an artistic rendering of an historic march held in Johnson City on October 7, 1916.



The design features portraits of many of Johnson City's leading suffrage activists as well as national and local leaders in relevant movements; creating visual bridges as phases [phases are further explained below] from the early Suffragist ancestors onward through other enfranchisement activists ultimately leading to a diverse grouping of current people who have benefited from their sacrifices. No currently living people are depicted. The mural also recognizes the fact that the 19th amendment did not grant all women the right to vote as it depicts four stages of legislation that impacted enfranchisement during the 20th century. Seen as a "passing of the torch," beginning with the ratification of the 19th amendment in 1920, the mural illustrates the Snyder Act of 1924, which gave citizenship to First Nations people; the McCarran-Walter Act in 1952, which allowed people of Asian descent to immigrate and become citizens; and the passage of the Civil Rights Act in 1964, which made voting restrictions to African American voters illegal.

HISTORIC WOMEN'S SUFFRAGE EXHIBIT

AUGUST 2019-AUGUST 2020

Explore a display of The Hermitage Hotel's private collection of historic artifacts dating from the summer of 1920, when Suffragists were headquartered in the hotel. This display will be located in the lobby next to the reception desk, and will be open for all to see throughout the spring and summer of the centennial year.

WOMEN'S SUFFRAGE COMMEMORATION AT THE PARTHENON

MARCH 2020-MARCH 2021

The Parthenon and Centennial Park were the destinations for the years-long struggle and debate for a woman's right to vote. From March 2020 through March 2021 the Parthenon will celebrate this history-changing accomplishment with an exhibit spotlighting the creators of the Woman's Building at the 1897 Centennial Exposition, including a family-friendly 'Dress the Part' area and links between Athenian democracy and American voting rights. Public programming will include informal programs near Centennial Park's Tennessee Woman Suffrage Monument, a panel discussion of women's rights from ancient Greece to modern times, and a recreation of the Suffrage walk from the Capitol to the steps of the Parthenon.

RATIFIED! TENNESSEE WOMEN AND THE RIGHT TO VOTE

OPENING SOON 2020-MARCH 28, 2021

Nashville Public Library will open Votes for Women: The Legacy of the 19th Amendment. It will provide a space to explore the core themes surrounding women's roles, democracy and power. HER FLAG

SUMMER 2020

On Tuesday, August 18, around noon at War Memorial Auditorium, Her Flag will be revealed in coordination with the re-enactment of the vote at the Capitol building that morning. Her Flag is a nationwide art and travel project created by artist Marilyn Artus who is collaborating with a woman artist from each of the 36 states that ratified the 19th Amendment to create a big 18'x26' flag. Each artist created artwork inspired by this anniversary that Marilyn turned into a stripe. This event will be a public performance, stitching the final stripe onto Her Flag.
