HISTORY OF TENNESSEE FEDERATION & BPW/TN

In June 1919 approximately one hundred business and professional women met in the YWCA in Nashville, Tennessee, to stimulate interest in attendance at the organizational meeting in St. Louis, Missouri, for the purpose of establishing the National Federation of Business and Professional Women's Clubs, Inc. Present from four clubs in Tennessee were Miss Florence Arp, Knoxville; Dr. Elise Rutledge, Memphis; Miss Mattie Lou Alford and Miss Fletcher Farris, Columbia; and Mrs. W.A. King of the Altrusa club of Nashville.

As an outgrowth of that meeting, Fletcher Farris of Columbia was elected delegate and Dr. Elise Rutledge of Memphis, alternate to represent Tennessee in St. Louis at the organizational meeting of the National Federation of Business and Professional Women's Clubs, at Hotel Jefferson in St. Louis, July 14-17, 1919.



In addition to Miss Farris and Dr. Rutledge, those attending from Tennessee were Miss Leora Fellate, Memphis; Mrs. W.A. King, Nashville; Miss Louise Neilson, Knoxville; and Miss Bertha Childs of Nashville. History reveals that Miss Childs was elected a vice-president of the national federation.

Early in 1920, Mrs. Ethel Crabtree of Chattanooga became interested in forming a state federation and had much correspondence with business women in Tennessee. By reason of the interest expressed, a call went out to all the business and professional women's clubs in Tennessee (about twenty at that time) to convene in Chattanooga in July.

On the afternoon of July 3, 1920, a group of women representing seven business and professional women's clubs of Tennessee met in the Hotel Patten, Chattanooga Tennessee, and agreed that a state federation should be formed. By seven o'clock that night the group was having dinner together at "The Hitching Post," a rustic tearoom in Chickamauga Park, and the Tennessee Federation was an accomplished fact. The seven charter clubs of the Tennessee Federation were Chattanooga Business and Professional Women's Club, Chattanooga Business Women, Columbia Business and Professional Women's Club, Jackson Business and Professional Women's Club, Memphis Business and Professional Women's Club, Memphis Business and Professional Women's Club, and Business and Professional Women's Club of Nashville.

During the years, in addition to Miss Bertha Childs, elected vice-president at the organizational meeting, Tennessee has given to the National Federation of Business and Professional Women's Clubs, Inc., two outstanding national presidents, Miss Charl Ormond Williams and Miss Osta Underwood; two national treasurers, Mrs. Sara C. Bruce and Miss Wanda Carter (Bates); recording secretary and 2nd Vice President, Miss Ann Scott; an executive secretary, Miss Elinor Coonrod; a national parliamentarian, Miss Margaret Heath, who served longer than any other person in a national position; and a number of national committee chairs and members.

Proper Care for Cloth Masks

This information was obtained from the CDC website.

Wet & Dirty Masks

- Wet or dirty masks should be keep it in a sealed plastic bag until you can wash it.
- Wash wet or dirty masks as soon as possible to prevent them from becoming moldy.
- Wet masks can be hard to breathe through and are less effective than dry masks.

How to Wash & Dry Your Mask

- Masks should be washed whenever they get dirty or at least daily. If you have a disposable face mask, throw it away after wearing it once
- .If using a washing machine you can include your mask with your regular laundry. Use regular laundry detergent and the appropriate settings according to the fabric label.
- If you are washing by hand, wash your mask with tap water and laundry detergent or soap .Rinse thoroughly with clean water to remove detergent or soap.
- If using a dryer to dry your mask, dry completely in a warm or hot dryer.
- If hanging your mask to dry, hang your mask in direct sunlight to dry completely. If you cannot hang it in direct sunlight, hang or lay it flat and let it dry completely.

Classic Pecan Pie

In celebratation of the upcoming holidays and the annual pecan fundraisers hosted by both Elizabethton BPW and Rockwood BPW. Here is a classic pecan pie recipe for you to try this season! If you have a favorite pecan recipe, please send it along to publication@bpwtn.org to be featured in an upcoming issue!

What You'll Need:

- One 9-inch unbaked pie dough chilled
- 2/3 cup corn syrup
- 1 cup brown sugar
- 1/4 cup unsalted butter
- 2 teaspoons vanilla extract or 1 tablespoon bourbon
- 1/2 teaspoon cinnamon
- 3 large eggs
- 11/4 cup chopped pecans

Instructions:

- 1. Preheat the oven to 350F degrees and position the oven rack in the bottom 1/3 of the oven.
- 2. Take the pie dough out of the fridge and let sit at room temperature for about 10 minutes.
- 3. On a lightly floured surface using a floured rolling pin, roll out the dough into a circle about 12 inches in diameter
- 4. Lightly dust the bottom of a 9-inch pie plate with flour and transfer the pie dough to the pie plate. Lightly sprinkle flour on the inside of the pie crust. Then fold over the edges of the pie dough and crimp with your fingers or press down with a fork.
- 5. Place the pie plate and crust in the fridge as you make the filling.
- 6. Add the corn syrup, brown sugar and butter to a medium saucepan over low heat. Melt together until the sugar is no longer grainy and the butter is melted, stirring occasionally.
- 7. Remove the pan from the heat and whisk in the vanilla extract (or bourbon) and cinnamon.
- 8. In a separate bowl whisk the eggs until frothy.
- 9. Whisk 1 tablespoon of the brown sugar mixture into the eggs.
- 10. Whisk the eggs into the warm brown sugar mixture, making sure to go quickly so that the eggs don't scramble.
- 11. Take the pie crust out of the fridge and place the chopped pecans in the pie shell, then pour the filling mixture into the crust (the pecans will float to the top).
- 12. Bake in the preheated oven for 50-60 minutes* then remove from the oven and let sit at room temperature for at least 4 hours before serving.

Note:

After about 30 minutes check on the pie to see if the crust is getting too brown. If it's already golden, place a piece of aluminum foil over top of the pie and continue baking.

Pie can be covered and stored at room temperature for up to 8 hours, then refrigerate. Store pie covered in the fridge for up to 4 days (although it's best after 2). Pie can be wrapped tightly and frozen for up to 3 months, then thaw in the fridge overnight. Bring pie to room temperature before serving.

A Regional director shall have served as area coordinator, district director, local organization president or as a member of the executive committee, The motion was seconded by 1st Vice President, Martha Ervin. The motion was adopted as presented.

Due to the deteriorating health condition of the previous treasurer, the committee could not retrieve all of the beginning of the fiscal year transaction. Therefore, data from the bank statements was used to restate the financial position.

Quicken is the official bookkeeping system for the organization.


